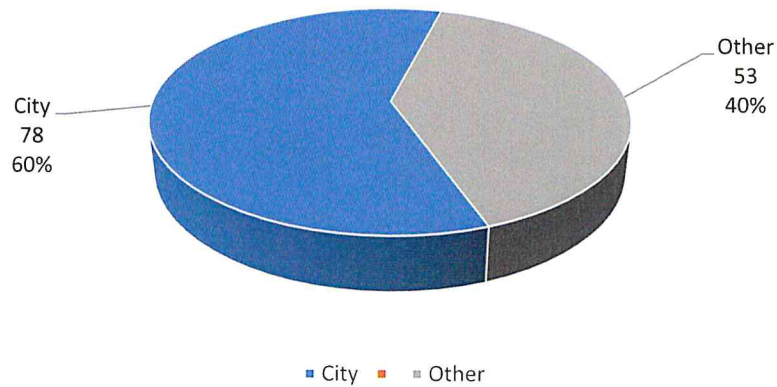


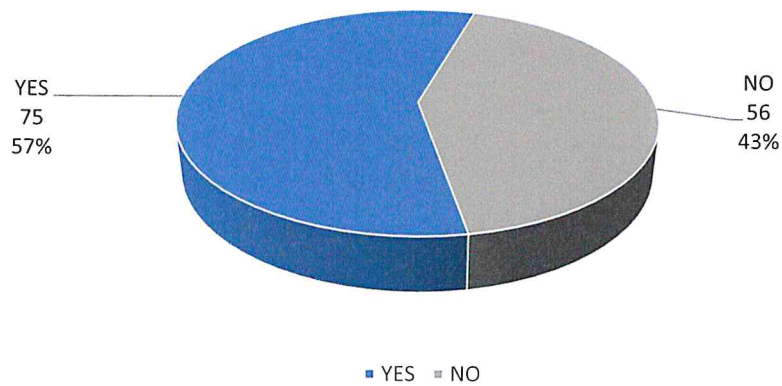

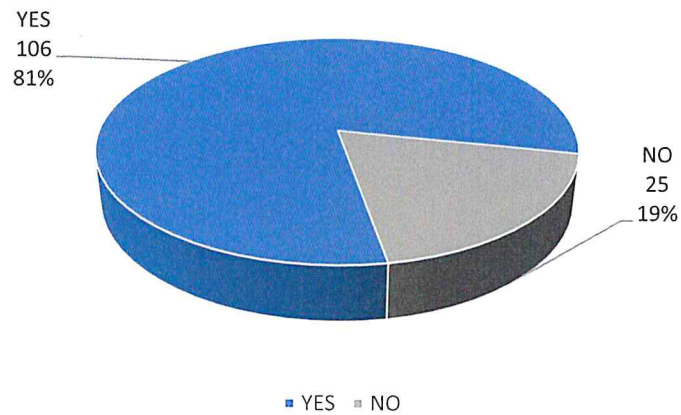
ATV Straw Poll - ALL Responses

ALLOW IN DOWNTOWN ONLY?

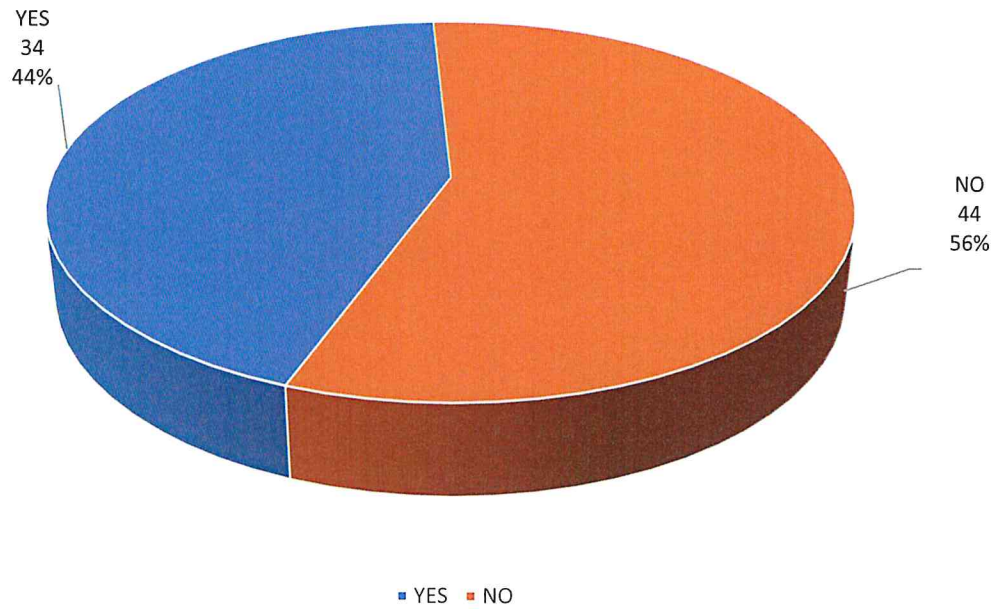

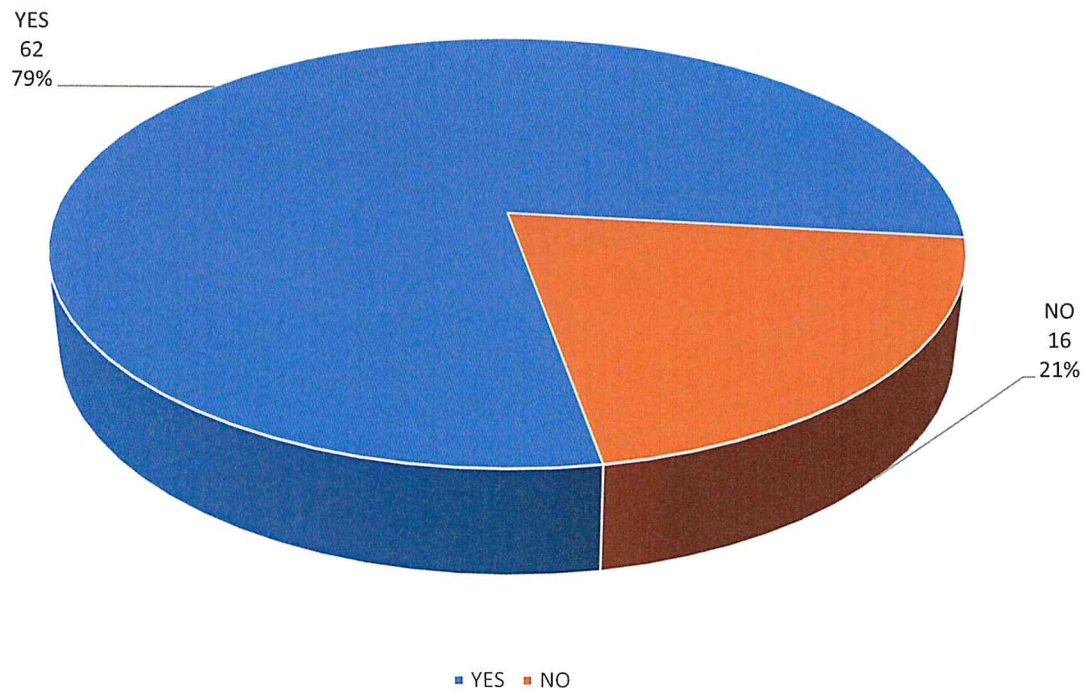
OPEN ALL CITY STREETS?

Would you be in favor of allowing ATV/UTV traffic in the DOWNTOWN AREA only?

NO – Comments (Why Not)

- 1. The safety of all patrons to BRF is far more important than undocumented perceived small increase in revenue from ATV/UTV patrons. 2. The City is too attractive & inviting to incur distraction from dirty/noisy ATV's/UTV's
- ATV users have over 100 miles of trails, specially built for them, in Jackson County. More miles if they head into Clark County. ATV owners can use their cars if they want to come into BRF. ATVs are noisy (contrary to Tom Cooper's comments comparing them to dump trucks... Dump trucks are loud much of the time.) We already have ordinances against using lawn mowers or doing construction jobs, between 9 PM and 7 AM...at the very least, this ordinance should apply to ATVs as well. Policing the ATV riders downtown will be a problem from time to time. Our police should be able to allocate their activities to more important things. And, what happens late in the evening when the ATV riders decide to drive around the residential areas in town? Some of them probably intoxicated. This won't be easy for the police to handle. And the idea that allowing ATVs downtown will somehow quickly repair the damage done to businesses by Covid 19 is specious at best. Yes, the businesses could use a boost...but this isn't the way to do it. Then there's the bridge to deal with...the potential for "problems" on the bridge is real.
- Because I don't think it should be only the downtown area. The citizens of BRF should be able to ride their ATV/UTV to the trails instead of having to trailer them.
- Cause that would mean access to business
- Having only the down town would restrict access to and from the outlying portion of town. Downtown parking lots would be full of trailers. No, all BRF roads need to be open.
- I do support there being ATV/utv access to the downtown area but I said no because I feel like it should be for ALL city streets and not only the downtown area like the question asks.

A lot of the concerns brought up at the meetings has me saying what is the difference between a motorcycle and a atv/utv? When on the roads they all have to follow the same laws and regulations out there for all moving vehicles on public roads, if not they get tickets, which is more money for our city as well. People brought up their concern about drinking and atv use but how is it any different than allowing poker runs for motorcyclists. Like Tom Cooper said, at first there may be more traffic along city streets because it's new and people want to check it out but after time it will only be the city residence hoping on and off the trails from their house.

- The residential area is quiet & safe - do not need the added noise. Could hamper the safety of little children. Could possibly turn into a drag strip.
